
**ORDER**

- 1) An interim Order of stay of execution hereby issues in favour of the Applicant restraining the Respondents from executing the Judgment in Civil Appeal No.260 of 2017 pending hearing and determination of the main application for stay of execution.
- 2) The Applicant bank is hereby ordered and directed to deposit with the Registrar of the Court of Appeal a bank guarantee of UGX.170,000,000/= (Uganda Shillings One Hundred and Seventy Million only) within a period of 10 days from the date of Consent/delivery of ruling failure of which execution issues immediately.
- 3) Court issues no Orders as to Costs.
- 4) Registrar is hereby Ordered to fix the substantive Application for stay of execution within 10 days from date of the Consent/delivery of ruling, the substantive/main application for Stay of execution is to be served on the Respondents within 2 days from date of the Consent/delivery of ruling i.e 25<sup>th</sup> April 2023, reply by 3<sup>rd</sup> May 2023 and rejoinder by 8<sup>th</sup> May 2023.
